
Overview

The Employment Standards Tribunal was established on November 1, 1995 under Part 12 of the *Employment Standards Act* (the "*Act*") as an independent agency with a mandate to conduct appeals of Determinations issued by the Director of Employment Standards and to reconsider decisions made by the Tribunal.





Average time to Decide Appeals and Reconsiderations

Generally, a case before the Tribunal is decided within 90 days of receipt where the case is decided solely on the basis of written submissions from the parties. On occasion, Tribunal appeals may take more than 1 year to adjudicate.


* Note:

- In Fiscal Year 06/07 the 4 associated cases were decided based primarily on written submissions. The appeals were received in Fiscal Year 03/04. Multiple decisions were issued, one of which was based on a combination of an oral hearing held in 2003 as well as written submissions.

Oral Hearings versus Written Submissions (% of total cases)


The Tribunal may decide cases based on either written submissions only or by a combination of an oral hearing and written submissions. Since fiscal year 03/04, Tribunal decisions are based primarily on written submissions only.

Reconsideration Decision Outcomes (% of total cases)

Since inception, the Tribunal has received 513 requests for reconsideration. This represents a request rate of 7.58% of total files. The reconsideration requests resulted in the Tribunal, on average, confirming 86% and altering or cancelling 14% of its original decisions.
